RELIGIOUS PERSECUTION BY CHIEF KEVIN LUNSFORD AND HPD

The Huntsville Police Department, under the direction of Chief Kevin Lunsford has been derelict in their duties due to Lunsford's extreme prejudice against me and our church because I am NOT a Christian.

HPD officers refused to investigate a gang of "Christians" that tore down our anti-death penalty sign or to fine a thief that stole our church sign because he wore a big Christian Cross.

Shocked, I went to see Lunsford and ask him to fine the thief \$5 and let him go.

Lunsford said that the thief committed no crime as Jesus was in favor of the death penalty, even wanting for innocent people to be executed so that they "could be with Jesus sooner".

He then told me directly and with malice that I am "GOING TO BURN IN THE FIRES OF HELL".

When a gang of druggies, invaded our \$600,000 house at 1700 Ave S, setting up a druggie camp in the woods behind the house,

and running rampant through the neighborhood HPD REFUSED to make any arrests that would have saved our house from being virtually destroyed.

The house was filled with drug paraphernalia. We believed that there was a meth lab in the basement, stolen credit cards were found, and the head of the druggie gang had a criminal record from being incarcerated in TDCJ.

The druggies were hostile and I believe on some really bad drugs, perhaps embalming fluid, crack cocaine, huffing paint and other drugs that cause hostility.

Due to COVID prohibitions, we couldn't even attempt to evict them and we were scared that if we were eventually able to evict them they would retaliate and blow up the meth lab.

HPD did nothing to protect our property, the neighborhood, or us from hostile assault.

After, the fire, we spent tens of thousands of dollars cleaning up the lot and making what was left of the house architecturally beautiful and converted the property into an urban wildlife sanctuary, with the building serving as a shelter for a family of vultures that are protected by both Federal and State Law.

The City of Huntsville is completely and totally responsible for the failure to take action to address the police department's OFFICIAL MISCONDUCT and ABUSE OF POWER and began harassing me repeatedly, abusing their powers to cause me great emotional and financial distress as a senior citizen while ignoring the dozens of actual derelict and dangerous structures in Huntsville.

City officials are in blatant disregard for State Law: in regard to ABUSE OF OFFICE and ABUSE OF OFFICIAL CAPACITY.

The U. S. DEPARTMENT OF JUSTICE: OFFICE OF JUSTICE PROGRAMS, two of which are Police Corruption and The Abuse of Power.

HPD has abused their power against me as early as around 1969 and I was assaulted by corrupt cops in front of my office and thrown in jail for taking photos of CRIMINAL TRESSPASS and at least \$500,000 in damages to our historic assets under the direction of my attorneys. When my attorneys left, a gang of dirty cops, apparently under the direction of Darryle Slaven, who was trained by Kevin Lunsford, severely violated my Civil Rights, and was recently elevated to Chief of Police, a position he certainly does NOT deserve based on his past history and the current history of HPD's failure to even arrest the three men that stole \$100,000 from me as well as protecting whoever murdered our daughter two years ago.

I do not know of any citizen that has been singled out for continuous harassment and caused to spend at least \$76,000 to date on the wildlife shelter, when the threats and harassment and charges against me that were filed on August 9, 2022 were dismissed on August 24, 2022 after spending over \$50,000 to get the corrupt city officials off my back when in fact it was the corrupt cops that should pay for the damages caused by their refusal to arrest a gang of trespassers, and druggies.

Then six months later the illegal harassment began again on January 18, 2023 based on what I consider to be OFFICIAL OPPRESSION based on lies.

The Citation stated that the structure was DILAPIDATED, which it was NOT!!!, and that there was rubbish, garbage, trash and debris, all of which had been taken to the city dump long before Jan 18, 2023.

The next day the corrupt city officials send a notice that I was going to be charged \$611.00 for a 'VACANT STRUCTURE OR LAND' and another \$611.00 for a bogus "FAILURE TO REMOVE TRASH AND DEBRIS".

On February 23, 2023, the same corrupt city officials abused their power again to threaten me with ARREST.

They are doing whatever people with a long history of hating me, wildlife, native trees and other native vegetation ORDER the corrupt officials to do to harass and threaten me for no reason.

The City Official most personally responsible for the ELDER ABUSE, OFFICIAL MISCONDUCT, and ABUSE OF POWER is our City Manager, Aron Kulhavy.

He is TOTALLY aware that he is abusing his office for zero legitimate reason unless our ethically bankrupt Mayor, Andy Brauningner ORDERED him to abuse his office and position to harass me, and try to force me to violate both FEDERAL and STATE laws that demand the protection of our Vulture and other species of migratory birds.
