## EXTREME RELIGIOUS DISCRIMINATION and PERSECUTION

I am NOT a CHRISTIAN. Kevin Lunsford's Cult teaches that I am going to burn in the fires of Hell for Eternity. Thus, based on my experiences he does not feel the need to protect our Church and other properties from vandalism, theft, criminal trespass, druggies or arson.

JESUS, likewise was NOT a CHRISTIAN. Jesus was an Ethician and our Ethician Church and Ethician Foundation are based on Jesus' ethical principles and NOT on the misogynistic, penis obsessed Paul, that I believe virtually ruined Jesus' simple message of love, charity, peace and the protection of God's Holy Creation.

Kevin Lunsford has targeted me for extreme religious discrimination and persecution that has cost us hundreds of thousands of dollars in damages to one of our most valuable properties.

My complaint is NOT against HPD but against the BAD APPLE that has tarnished it. Most if not all of the officers are good people who believe in public service but I can sense that they are afraid to confront Lunsford, just like good Republicans are afraid of Donald Trump and fear retaliation if they disagree with him.

A gang of druggies invaded our house at 1700 Avenue S and were operating 24/7 from the house, throughout the neighborhood and in an encampment in the Gibbs woods along Normal Park.

The police were called by the next door neighbor, Tom Angel, multiple times to report criminal activity yet nothing was ever done to take the dangerous druggies to jail, while at the same time the Police Beat in the Huntsville ITEM reports on arrests of people smoking or having a marijuana cigarette butt in their vehicle.

We were quite simply afraid of the druggies due to their violent demeanor when hopped up on who knows what and we suspected PCP, Embalming Fluid, Meth, Huffing Paint, Crack Cocaine and perhaps Designer Drugs.

Our property manager Kristi Zeltner warned me that they would burn the house down, and I was afraid that if I evicted the trespassers, squatters, and druggies, they would burn the house down in retaliation so I was working to carefully extract not only the druggies that had invaded the house without permission as well as the only two quasi-legal tenants – a drugged out woman and her daughter. She was not authorized to have roommates when two druggies got in a fight, started a fire and caused half of the house to explode, which was a blatant case of arson. The police know the names of the arsonists yet, to my knowledge have done nothing to put them away.

According to reports after the fire, stolen credit cards were found and the house was full of drug paraphernalia. When we told the police about the crack pipes, bongs and who knows what else we were told that the perps would have to be observed using the items in order to be arrested and for us to throw the paraphernalia into the garbage.



Subsequently, druggies continued to use the burned out structure yet I believe that only one trespasser ever went to jail and that was due to an outstanding warrant.

The reason that I depended on neighbors to call the police is that Kevin Lunsford had already proven to me to be a RELIGIOUS ZEALOT and EXTREMIST who believes that Jesus is in favor of executing INNOCENT people, “so that they can be with Jesus sooner”.

I have opposed the death penalty since around 1957, when Don Reid told me that he believed that one in six people put to death were completely innocent.

So our church installed an anti-death penalty sign that said:

‘Thou shalt NOT (with NOT crossed out) Kill in Huntsville, City of DEATH – Make SATAN HAPPY – Make Jesus CRY.’

A “Christian” club or organization operates out of a metal building on 15<sup>th</sup> Street, which is around the corner from where our CHURCH-owned anti-death penalty sign was attached to our Smither Warehouse building.

In plain view of our security camera a group of the “Christians” jerked half of the sign down onto the sidewalk and stomped on it. They tried to jerk down the other half but were unsuccessful.

As far as I know, no one was ever arrested or charged with the crime of vandalizing church property.

Had I, George Russell, gone to any church and vandalized and stole church property I would no doubt still be in jail.

Sometime later, a man with a "Christian Cross" around his neck stole the sign. Our Security Guard got the license plate number and called the police.

The police tracked the man down and he was told to return the stolen sign.

If my recall is correct there were three officers that had apprehended the thief. I asked them to take him to jail, fine him \$5 and let him go as to my knowledge none of the many vandals, thieves, squatters, or people caught red-handed committing crimes against me and our church and museum properties ever went to jail which is why I asked that he be taken to jail, fined \$5 and released.

The three officers refused to arrest the man because he was (now get this) wearing a Christian Cross around his neck so he had committed no crime.

Apparently all three officers were members of the same cult as the thief and the Chief of Police.

I said that if the police refused to even fine the man \$5 then at the very least I wanted him to tell me exactly what went through his mind to cause him to steal the sign.

Broderic Carter, aka Choo Choo, was my witness when we went into our Library of Texana.

The man was cocky and arrogant, knowing that he would not be arrested for the theft.



I asked: "Is Jesus in favor of the death penalty?" Answer: "Yes because if he was against it he would have let the two guys go that were being crucified on either side of him while he was nailed to the Cross.'

I then asked: "Is Jesus in favor of executing innocent people?" Answer: "Yes, because they get to be with Jesus sooner."

"Then tell me about what you have been taught in your church."

He said: "All you have to do to go to heaven is say, I believe in Jesus, Jesus is my savior, please forgive me."

But that's not all: He continued, "Once saved, always saved, and you can never be unsaved and ALL FUTURE SINS ARE PRE-FORGIVEN IN ADVANCE."

So now I know why a pedophile deacon in one of the cult's local churches, molested babies repeatedly over a period of several decades without fear that he might be unsaved and go to hell. Of course he was never arrested and never suffered any negative consequences that I am aware of.

Unaware that Lunsford was a member of the same cult with the same belief I went to see him and asked him to take the guy to jail, fine him \$5 and let him go.

Lunsford totally agreed with everything the thief had told me and refused to acknowledge that he had done anything wrong and refused to even fine him \$5 so that a message might go out advising other vandals, thieves and criminals that if they commit a crime against our foundation, our Church or against me and my wife, they will at least have to go to jail and be fined \$5 and then let go.

It is obvious to me that Lunsford PURPOSEFULLY refused to take any action against the DRUGGIES out of EXTREME RELIGIOUS DISCRIMINATION and PERSECUTION against me and our Church.

Any drug detective, spending any time at all observing the criminal activities at 1700 Ave S and the surrounding area would have obtained a search warrant, would have taken the criminals to jail and our valuable uninsured house would have been saved.

AFTER THE FIRE: a search warrant was issued and in addition to drug paraphernalia the inventory of stolen items included:

“Multiple bank/credit cards, check books and wallet belonging to multiple people who do not reside at this residence and was found in room identified as LAUREN’S.”

“Bag containing multiple bank/credit cards, belonging to multiple people who do not reside at this residence and was found in room identified as HEATHER’S.

The stolen property was seized by DARREN PARKER.

I am unaware if any of the known criminals were given jail or prison sentences for the multiple crimes, most especially the arsonists.

Due to the nature of the BLATANT RELIGIOUS DISCRIMINATION against our church and what I consider to be persecution against me for not being a member of Lunsford and the sign thief’s cult, I am hereby filing a claim against the City of Huntsville for allowing Lunsford to discriminate against me and our Church.



Of course, the corrupt Insurance Company that the City uses will deny this legitimate claim, making it necessary to file suit against Lunsford personally for his role in refusing to take action against vandals and the thieves that stole the sign more than once. It was never recovered the second time it was stolen.

But more important was Lunsford's role in allowing a MAJOR DRUGGIE OPERATION to go on for week after week in plain sight and doing nothing about it until the meth lab exploded due to arsonists setting fire to the house.

To date, our CORRUPT MAYOR has refused to pay for the \$50,000+ plus in damages to our Children's Museum that he promised, which is just one more indicator of hate and prejudice directed against me and our CHARITIES.

## THE FIRST AMMENDMENT

Lunsford has every right under our CONSTITUTION to believe anything he wants in regard to his personal religious beliefs and to attend any church or cult that he wishes, but he has ZERO CONSTITUTIONAL RIGHT to punish me for being an Ethician rather than a Fundamentalist Christian.

His duty to the public and the taxpayers that pay his salary is to protect all citizens regardless of their faith which do not match his beliefs.

Lunsford needs to take his "god" and his "Jesus" back to his own home or church and not use his 'faith' to allow CHRISTIAN CRIMINALS a FREE PASS because their "SINS" have been PRE-FORGIVEN in advance.

We fear that because the person, according to all evidence, caused the death of our daughter, wears an oversized 'Christian Cross' around his neck, Lunsford will give him a FREE PASS.

So bottom line: The City owes us the PROMISED \$50K for the human feces that backed into our Children's Museum due to a defective sewer line and the estimated \$300K in damages to 1700 Ave S, due to Lunsford's refusal to raid the obvious DRUGGIE HANG-OUT and take the criminals to jail, which would have saved the house from the ARSON FIRE and METH-LAB EXPLOSION.

If the City refuses to pay for the damages due to Lunsford's obvious discrimination and persecution against me for NOT being a part of his cult beliefs, then Lunsford should pony up and pay for the damages personally.

Apparently Lunsford and/or members of his cult that are employed by the City have UNCONSTITUTIONALLY placed "In God We Trust" on the back side of every police vehicle.

As a theologian and Constitutionalist, it offends me each time I have to see that ILLEGAL MESSAGE.

There are over 3,000 different "gods" on our planet and some say even more if the entire list of Hindu god's is included.

So just which of the 3,000+ gods are we supposed to trust. I certainly do NOT trust Lunsford's Cult's God, so please follow our Constitution's demand that we separate CHURCH and STATE.
