## ORGANIZED CRIME: RICO

In my experience “organized crime” has ruled Huntsville for many years. Headquarters of the Dixie Mafia was at 1239 19<sup>th</sup> Street. That is where Peter Kay, Charles Harrelson and the Chagra Brothers planned the murder of Federal Judge Wood in San Antonio.
