Not knowing that the chief of police was a religious fanatic and zealot I asked chief to fine the thief \$5 which is when he told me that I am going to "burn in the fires of hell" and concurred with the thief.

Our beautiful home at 1700 Ave S would still be intact if HPD had taken the squatters, vandals, thieves and druggies to jail. We were afraid to evict them because they were hopped up on drugs, had violent tendencies, and we believed that they would blow up- the house in retaliation. (For around a year it would have been illegal to evict them due to Covid)

They blew up the meth lab in the basement anyway and HPD knows the names of the two arsonists and knows the names of the witnesses to the lighting of the fire by the two arsonists yet, as far as I know, has done nothing.

Our 1845 Convivencia church was burned to the ground, obviously by professional arsonists because of the Star of David sign in the dogtrot and apparently, because a high percentage of radical Christians believe that since "Jews killed Jesus" they are still responsible for his alleged death on a cross to this day.

She was given her lot by my political enemies and has a history of harassing me for no good reason. A few months ago one of our big oak trees died on our lot on Woodland Lane. It was very close to her driveway and our man lift was at 1700 Ave S. I asked permission to use her driveway to be able to easily reach the tree and she and her husband refused, costing us time and money and having to destroy native vegetation on our property to build a "road" to be able to reach the dead tree from Woodland Lane.

I believe that it is against the law to harass people by making frivolous or false complaints.

I gave Aron a packet with 100% documented proof of the theft of \$100,000 from me. Aron told me that he gave the documentation to HPD but to date HPD has not arrested the three men involved in the felony and I still don't have my \$100,000, nor has anything done to retrieve the million or so dollars that my wife and I were defrauded out of.

My wife still has not been able to visit our African Museum that she financed 50% of due to EXTREME violations of the ADA. Even though I have filed a formal complaint with the ADA folks the city still could care less about the safety of visitors, especially handicapped Black or White people.

So bottom line: THIS CITATION IS JUST HARASSMENT MEANT TO TERRORIZE A 77 YEAR OLD SENIOR CITIZEN AND HIS HANDICAPPED WHEELCHAIR CONFINED WIFE.

It is my opinion and I believe the opinion of the majority of Huntsville residents, voters and tax payers that the library has been professional managed by local staff for many years. It appears to me that this action was in violation of the "open meetings act" and that any contract should be voided immediately.

Under the Texas Open Records Act, please provide the following information within 10 business days as prescribed by law.

- 1. Records of any and all communications, whether in writing or electronic along with any notes, records of phone calls and any other documents between the Huntsville Police Department and City Staff in regard to (I believe illegally) sending a police officer or officers to disrupt the management of our public library and violate the First Amendment of the US Constitution by removing legal displays of books in said library.
- 2. A list of all private companies asked to bid on managing our public

library.

- 3. Documents in regard to any and all communications between the city and any company that bid on the contract to manage our public library.
- 4. Any record associated with communications between any member of city staff and any member of city council including the mayor in regard to said contract.
- 5. Any Texas law or statute that made it legal for negotiations, discussions, and decisions to be made in secret sessions without the inclusion of the public, librarians, friends of the library or any other group or board associated with our public library in any way, plus any communication between the City Attorney and anyone associated with the City of Huntsville in regard to the alleged legality of said raid into our public library and its disruption.
- 6. Any Texas law or statute that allows for police officers to enter a public library and without legal authority to remove legal displays of books or other items of interest to the public.
- 7. Any record associated with any city council member, mayor, city manager or other person communicating with HPD about said "raid" on our public library and the legal authority to order entry and disrupting the operation of Huntsville Public Library.
- 8. Any law that was or was allegedly being broken by library staff that required police to enter the library and cause the removal or any book or display.
- 9. Any law that allowed the city to summarily terminate employment of any library staff member or employee without notice or cause.

The arson fire that destroyed our house at 1700 Ave S meets the definition of a HATE CRIME by the FBI.

The former chief of police told me that I am going TO BURN IN THE FIRES OF HELL because I am NOT a Christian.

He refused to fine vandals that ripped our church's anti-death penalty sign of the wall of one of our museums and stomp on it.

He refused to fine a young religious extremist even \$5 for stealing our church's sign.

I hired a PI to gather evidence of religious based lack of police protection and of me being harassed and threatened by the city, even after I had to spend at least \$50K making the ruins presentable, while Huntsville is a horrific slum, the main eyesore being Judge Danny Pierce's dump on Sam Houston Avenue that he has refused to repair for decades.

It appears that the City of Huntsville is not only protecting arsonists, thieves and other criminals. And it was the Chief of Police that aided and abetted crimes against me based on his STATED HATRED in telling me that I AM GOING TO BURN IN THE FIRES OF HELL AND THAT JESUS WANTS INNOCENT PEOPLE TO BE EXECUTED SO THAT THEY CAN BE WITH JESUS SOONER.

Aron; I tried to convince you to fire the chief and order HPD to NOT USE THEIR RELIGIOUS EXTREMISM to protect criminals.

Kevin Bayal should be investigated for PUBLIC CORRUPTION along the our Mayor, for lying about the city having flooded our Childrens Museum and then promising to pay for the damages and never paying one penny.

The house (now a wildlife shelter) is perfectly safe and the city agreed that our brush/compost pile was legal and that two windows on the second floor in the back could be left open for our vultures and any other wildlife that might want to use the shelter.

Now the city has changed its mind and wants us to seal the windows which would eventually kill the vultures and babies from the eggs that they have laid in the house.

Thanks in advance for any help you can provide to get the city off my back. I'm the guy that sued the Fed Govt to protect the Red-cockaded Woodpecker and its habitat. We have been working with University of St. Mary's to study our Red Wolf ghost alleles (aka DNA). We have one active Bald Eagle nest and a significant population of Alligator Snapping Turtles being studies by the University of Houston: Clear Lake.

First, yes, we and a number of other neighbors have been in touch with the City regarding your burned house. That is true. After more than 3 years, it is terribly frustrating to have the home and yard remain in unlivable conditions. We see a number of cats and other vermin regularly going in and out of the house,; a pair of buzzards roost inside and stop on our roof when exiting, making quite a mess; the home is bound to be full of mold and mildew since it is open to the elements—several neighbors have experienced worsening allergy problems; the burn smell when it rains is quite strong. NOT The weeds, piles of wood and other debris around the house are a breeding ground for rats, mice, snakes, insects, and other pests. It is everyones hope that you will complete restoring the home as soon as possible, rent it to a nice family or sell it. It was, and can be, such a beautiful place. As it is now, it is a health, fire and safety hazzard to the entire neighborhood.

In regard to why no one reported what was going on at the home before the fire, you are terribly wrong. A number of us called the police, fire and even health department on numerous occasions. Joe spoke with you directly at least once; some called you and/ or your office—one person being told you could do nothing because they were paying the rent. You know, of course, that you were the one who would have to initiate an eviction, not neighbors or the City. We all felt we did everything we could to correct a really horrendous situation.

As to the death of your daughter, Joe and I were terribly sorry when we heard the news and knew how awful such a tragedy had to be for you and your family. Having a daughter ourselves, we have the utmost sympathy for you. However, we know nothing of the circumstances surrounding her death and have no ability to do anything regarding the investigation and its outcome. Neither of us is sure what you mean about not talking to your PI?? No investigator has ever approached either of us to discuss the case. And, there would be absolutely nothing that we could add, if he did.

Going forward, we and the entire neighborhood look forward to having this "house" matter come to a satisfactory conclusion as soon as possible. It has been a long 3 years!

I have spent at least \$60,000 making the exterior of the house compatible with the neighborhood. It can never be restored as a human habitation as that would cost at least \$300,000 and the man that murdered our precious daughter defrauded us out of at least a million dollars, got us in debt \$300,000 and then conspired with Polk County Title and a local attorney to actually steal \$100,000 leaving a complete paper trail that was given to the police many months ago by Aron Kulhavy and there have been no arrests. The police knew the names of the two arsonists and the names of eye witnesses yet refuse to arrest them.

We are donating the property to The Ethician Foundation to serve as an urban wildlife sanctuary or you may wish to purchase it for \$200,000 before we deed the property to our foundation.

It is NOT a health, fire or safety hazard to the entire neighborhood. I find that untrue statement to be bordering on libel.

I have been over there many times when it is raining and I NEVER smelled and "burn smell" that can cause allergies. Everyone is suffering from allergiees at this time of year and it is NOT from breathing in a burn smell.

It was the responsibility of the police to take the druggies to jail and they were dangerous being hopped up on who knows what kind of dope.

During COVID we were prohibited from evicting them and when we could evict them we discussed our fear that they would retaliate and burn the house down.

I was trying to ease them out of the house but the drug dealers refused to leave and as trespassers the police should have gotten them out.

Chief Lunsford hated me and refused to even fine vandals and thieves that ripped down and later stole our church's anti-death penalty sign. All I asked was for HPD and later Lunsford personally to fine them \$5 and let them go.

We see a number of cats and other vermin regularly going in and out of the house,; a pair of buzzards roost inside and stop on our roof when exiting, making quite a mess; the home is bound to be full of mold and mildew since it is open to the elements—several neighbors have experienced worsening allergy problems; the burn smell when it rains is quite strong. The weeds, piles of wood and other debris around the house are a breeding ground for rats, mice, snakes, insects, and other pests. It is everyones hope that you will complete restoring the home as soon as possible, rent it to a nice family or sell it. It was, and can be, such a beautiful place. As it is now, it is a health, fire and safety hazzard to the entire neighborhood.

In regard to why no one reported what was going on at the home before the fire, you are terribly wrong. A number of us called the police, fire and even health department on numerous occasions. Joe spoke with you directly at least once; some called you and/ or your office—one person being told you could do nothing because they were paying the rent. Thank you for reaching out to the Service with your concerns over migratory birds. We do appreciate and understand your concern regarding migratory birds.

The Migratory Bird Treaty Act (MBTA) makes it illegal for anyone to take, possess, import, export, transport, sell, purchase, barter, or offer for sale any migratory bird, or the parts, nests, or eggs of such a bird except under the terms of a valid permit issued pursuant to Federal regulations. However, as long as there are no active nests present, there are many non-lethal methods available to landowners that can be used to deter birds. With the exception of eagles and threatened/endangered species, a landowner does not need a permit to use non-lethal methods to haze birds. I would suggest that you review the attached FAQ document put out by Wildlife Services and the Dispersal Techniques document put out by the USDA. They contain management techniques that can be used. View more information and the migratory bird species protected by the Act at https://www.fws.gov/birds/policies-and-regulations/laws-legislations/migratory-bird-treaty-act.php.

The City of Huntsville has been harassing me for decades because I have spent most of my life (I'm 77) trying to protect wildlife and their habitats.

For example, I filed the Federal Lawsuit that resulted in the protection of Red=cockaded Woodpeckers and their habitat. We purchased over 3,000 acres on 12 miles of shoreline and riparian habitat adjacent to Lake Livingston in E. Texas.

We have wild canids, that appear to have a strong Red Wolf gene component that has been studied by scientists from St. Mary's University in San Antonio.

Fighting poachers is a constant battle in E. Texas. My wildlife manager called the Game Warden a few minutes ago, who argues and is really unhelpful, and we recently had to put out another arson fire.

We recently established an urban wildlife refuge and spent upwards of \$100,000 to create a wildlife shelter that blends into the architecture of the neighborhood.

Our refuge backs onto over 10 acres of native forest ecosystems and our wildlife shelter is home to a family of Black Vultures.

The City has been harassing me and threatening me and trying to force me under huge fines and even jail time if I don't kill our Vulture family.

Yesterday we were forced to close all ingress and egress openings in the shelter and had to agree under extreme pressure to harm the birds for no reason except hatred of me and hatred of wildlife. Two city officials harassed my staff and police cars and policemen lied and intimidated me.

The officials came up with more insanity to harass me. I sent my staff over to check on the vultures and one was totally stressed out and attempting to go through the window glass. We opened the windows and the poor bird was able to escape and we left them open so that she can return to feed her babies that we believe are in the attic.

After my court date yesterday, the City gave me a new court date demanding that I harm or kill our vultures.

I want to press charges against the City Manager, Aron Kulhavy, that is orchestrating actual hate crimes against me because I am NOT a Christian. The Chief of Police told me I was going to burn in the fires of Hell and that Jesus likes innocent people to be executed so that they can be with Jesus sooner.

The police allowed and encouraged a gang of druggies to operate a meth lab out of our \$600,000 house that the druggies had invaded and eventually blew the meth lab up which destroyed much of the house, which we spent tens of thousands of dollars to convert into a wildlife shelter

The same police have been protecting the man that murdered our daughter and defrauded us out of at least a million dollars and along with two other men stole \$100,000. The city manager is in charge of the police yet refused to take action to clean up the department.

I know that these crimes are not under your jurisdiction, except FORCING ME UNDER THREAT to injure of kill our vulture family.

I would think that forcing a citizen to commit a Federal offense would be a crime. Thus I am hereby making a formal complaint and asking your agency to arrest the city manager for forcing me under threat to harm or kill our vulture family.

We desperately need help from outside law enforcement as even the game wardens are compromised.
