Sept 15, 2008 Darryle Slaven orchestrates a gang of rogue cops to assault me and throw me in jail. KEVIN LUNSFORD WAS CHIEF OF POLICE: 2010 – JULY 31, 2022

CHI ALPHA (an alleged Christian Club) jerked out church's anti-death penalty sign of our MUSEUM OF TEXAS FURNITURE and stomped on it in front of our security cameras and HPD refused to even fine them \$5. Then another man stole the sign and our security guard took down the license number of the thieves truck and the cops also refused to fine him \$5.

He said that his church, the Evergreen Baptist Church teaches “once saved, always saved, you can never be unsaved and all future sins are pre-forgiven in advance”.

I was astonished, so I went to see Chief Lunsford, not realizing he was even a more psychotic religious nut than the sign thief.

Lunsford, not only told me that his church teaches the same thing but went one step further, saying that JESUS LIKES FOR INNOCENT PEOPLE TO BE EXECUTED SO THEY CAN BE WITH JESUS SOONER and because I am NOT a Christian that “I am going to burn in the fires of Hell for eternity.”

When the wife of James W. Jones died several years ago, having lived at 1700 Ave S for many years, her daughter, Heather began to steal Mr. Jones social security check so no rent was paid for many months.

Heather then began to fill the house with druggies and they would roam the neighborhood and sell drugs from the decks. At least 4 sets of neighbors called the police, yet the police would do nothing to arrest the druggies. I went to see City Manager, Aron Kulhavy and asked him to fire Chief Lunsford for many reasons. Kulhavy admitted that it was his job to hire and fire police chiefs, yet Kulhavy reportedly ordered the police to leave the druggies and the drug house alone.

Before we or any other neighbors could convince HPD to take care of the problem, two arsonists started on January 29, 2020 that blew up the meth lab in the basement and caused hundreds of thousands of dollars in damages.

The cops know the names of the arsonists and we were told had witness statements, but as far as we know there have been no arrests for arson.

At the scene of the fire we were told that Heather had a criminal record and had been in TDCJ.

On Oct 16, 2024 I encountered Heather's daughter emerging from the yard at 1700 Ave S. She said she was nostalgic since she grew up in the house so I gave her a tour of the destroyed interior. She said that Heather was in jail in Woodville for parole violations.

It had been reported to me that Kulhavy has a drug addiction problem and that he walked his dog over to the drug house at 1700 Ave. S, every afternoon.

The druggies had also set up a druggie camp in the woods behind the house, operating openly for months.

Due to Covid and our fear that they would blow up the house if we tried to evict the druggies, I tried to ease them out by buying items from the house. Heather would take my money and then sell the items to third parties.

Some of the male druggies acted assaultive while obviously high on drugs, so we were afraid of them, hoping that the 4 sets of neighbors would eventually convince the police to raid the place and haul them all to jail.

Yesterday, there was apparently a drug bust on Ave M, with cop cars at the scene for hours.

Had the cops raided 1700 Ave S, we wouldn't have lost a \$700,000 house due to police malfeasance and corruption at the highest levels at City Hall.

We also get no help from the Mayor or City Council in regard to the wasting of millions of tax dollars for what I consider to be felonies due to the destruction of public property such as the recent demolition of City Hall which was in great condition to replace it with a monstrosity that cost multimillions and wouldn't have been needed for at least another ten years.

There should be a thorough investigation by the FBI or Texas Rangers in my opinion.
